- 2. The candidate for the Zoning Board of Appeals had to back out of his appointment due to family issues. I have three potential candidates to be considered. One opening is now, the other opening will be in January.
- 3. The 2026 tentative budget has been completed. We will hold a public hearing at next month's work session then pass the budget with any changes at our regular meeting in November. As has been for the past few years, the budget process is very challenging, but our staff and elected officials have done a great job in keeping any increases as low as possible. Currently, the 2026 budget related to property taxes is below the tax cap. More details will be discussed at the hearing.
